## Investigation Event Agreement and Release Form

For the purpose of this agreement, the term client(s) is defined as property owner, occupant, renter, agent, or representative of the property where the investigative event is being held. McInville Paranormal is the organization conducting the events on the client's property.

**Monetary Agreement:**

- A. It is agreed upon by both parties that the retaining cost to McInville Paranormal for the purpose of holding investigative events on client(s) property is in the amount of \$\_\_\_\_\_ per event. This will be paid to the client(s) day of the event.
- B. Additionally, Client's will be compensated with \_\_\_\_\_% of the total profit gained by McInville Paranormal from all ticket sales for each investigative event. This will be paid to the client within 14 days after the event to allow ticket sale processes to complete.

1. I (client as identified above and by signature below) hereby grant permission for McInville Paranormal to conduct an investigative event on my property indicated above and to gather, review and analyze evidence collected during that event, including witness statements, audio and video recordings, photographs and other scientific readings.

2. **HOLD HARMLESS** – McInville Paranormal assumes all responsibilities of personal injuries incurred while on clients property. McInville Paranormal will assume all responsibility for the condition, proper care and safeguard to all of the client's property while on the property. This includes cleanliness and trash collection of the property. McInville Paranormal agrees and guarantees to leave the property in exactly the same condition in which it was when first entered. All visitors for the event will sign a release form which releases McInville Paranormal and the

client of any liability of injuries incurred to the visitor while on the property.

3. PUBLIC ACCESS – Client(s) gives permission to McInville Paranormal for the purpose of this event, authority during the dates and times specified above, to give access to persons from the public who have purchased ticketed access to investigative events on client(s) property.

4. CLIENT RESPONSIBILITIES – Client understands and agrees to the following guidelines.

4.1. Client will at no time knowingly falsify any claims of paranormal activity before, during or after the investigation by McInville Paranormal.

4.2. The client(s) will make no false or misleading statements about the McInville Paranormal team and/or their paranormal investigation of the investigation site.

4.3. No media will be invited to witness, film or otherwise document the investigation event without the express permission of McInville Paranormal.

5. McInville Paranormal RESPONSIBILITIES – McInville Paranormal understands and agrees to the following guidelines.

5.1. McInville Paranormal will at no time knowingly falsify any claims of paranormal activity before, during or after the investigation of the client(s) property.

5.2. McInville Paranormal will make no false or misleading statements about the client(s) and/or their property.

5.3. No media will be invited to witness, film or otherwise document the investigation event without the express permission of the client(s).

6. EVIDENCE – McInville Paranormal investigation events are performed strictly for entertainment to the public. Any and all evidence will be analyzed and properly documented. But, the client(s) understands there is no guarantee of legitimate evidence due to public access and interference during the event.

6.1. Evidence will be collected using digital and analog audio and video recording devices, digital and 35mm cameras, EMF detectors, temperature monitoring equipment and any other equipment McInville Paranormal deems necessary. All data collected will be combined with other case files in a database for review and analysis. This data includes witness demographics, general site information, reported activity details and evidence collected. This data does not violate the confidentiality terms outlined in paragraph 2.

6.2. Client understands that upon request, McInville Paranormal will provide them with a written report including an SD card containing copies of only those photographs, video or audio clips which contain documented evidence of the paranormal and that McInville Paranormal will make the determination as to what constitutes evidence. Client further understands that all other photographs, video or audio recordings remain the sole property of McInville Paranormal and its members.

6.3. Client agrees not to release, publish or make profit from copies of documented evidence collected by McInville Paranormal and obtained during the investigation, such as photographs, audio or video clips, case reports, investigator field notes, etc. without the express permission of McInville Paranormal.

6.4. Client further agrees that members of the public that participate in the investigative event may collect evidence on their own devices such as cell phones, audio recordings, cameras or camcorders. These individuals are given permission to record, document and publicize their captures on any social media of their choosing. However, persons may not publicize any documented evidence or footage for profit without written permission by the client(s).

7. SUBSTANCE USE – There will be no alcohol drinking or illegal drug use in the investigation site during the investigation. Cigarette smoking is not allowed on the property except in designated areas specified by the client(s) only. Client understands that GUPF may suspend the investigation at any time if any person present at the investigation site is found to be using alcohol or illegal drugs, smoking cigarettes in undesignated areas or disrupting the investigation.

8. WEAPONS – It is agreed that any weapons stored at the location will be secured and at no time will they be available to any person at the investigation site including clients, GUPF team members or other interested parties unless prior agreed upon. Firearms and or weapons for personal protection in needed areas will be allowed by permission of the client(s) only.

9. TERMINATION – GUPF may terminate the investigation at any time at its sole discretion if any of the terms of this agreement are not followed. Additionally, The client(s) may terminate the investigation at any point during the course of the investigation process without stating a cause for such action. Client understands and agrees that if the investigation is terminated at their request GUPF may not provide client copies of any evidence or case notes and the relationship with GUPF will end.

10. RELEASE OF CONFIDENTIALITY -- I agree to allow GUPF held harmless and give permission for GUPF to publicize any and all data collected during their investigation of my property or location I am responsible for. This data may include video recordings, photographic imagery and audio recordings. I also agree to release atmospheric measurements that may have been collected during their investigation. This can include but not limited to atmospheric pressure, humidity, temperature, ion readings, emf readings, or radiation readings.

I DO agree to paragraph 10. And, I agree to fully allow GUPF to disclose any and all information including identity and data collected information as they deem necessary.

I NO agree to paragraph 10, but DO NOT agree to have my name or location made public. And, I elect to allow data and evidence be shared by GUPF with stipulating my personal identifying information be held in complete confidentiality.

I DO NOT agree with paragraph 10. And, I elect to have the GUPF keep all data and personal identifying information collected during the investigation held completely confidential.
